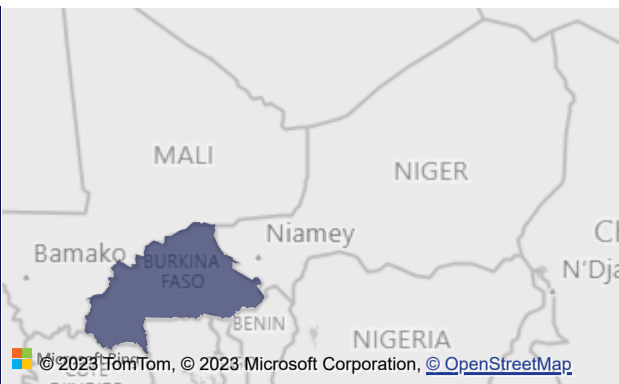


Key Action in 2022

1. Protection from Sexual Exploitation and Abuse (PSEA) was mainstreamed into the 2022 Humanitarian Response Plan and, safe programming and risk reduction activities and budget lines included into all Cluster's Action Plan.

2. Over 665,000 people attended sessions on gender-based violence and SEA awareness.

3. A 3-level- Inter-Agency Community Based Complaint Mechanism (National, Regional hub-based and community complaint communities) led by UNHCR and ACTED is progressively running and is guided by the United Nations Country Team/Humanitarian Country Team endorsed standard operating procedures.
