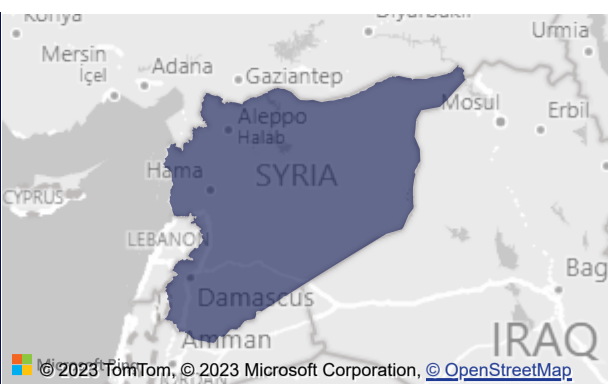


Key Actions
