


Key Actions

1. A two-year Protection from Sexual Exploitation and Abuse (PSEA) strategy was launched in Lebanon to establish a unified approach in preventing and responding to SEA aligned with global standards.

2. The Lebanon In-Country PSEA Network, guided by the Resident Coordinator/Humanitarian Coordinator and United Nations Country Team/Humanitarian Country Team, focused on capacity building, creating pool of investigators, and identifying SEA risks with support from UNICEF and UNFPA.

3. Efforts also included revising Inter-Agency PSEA standard operating procedures and creating contextualized Information Education and Communication material, aiming to enhance the effectiveness of PSEA initiatives in Lebanon.
