# IASC PSEA Technical Advisory Group (TAG) Meeting 15 January 2025 15:00-16:30 (GVA/CET)

# **Meeting Summary**

#### Introduction

The IASB PSEAH Team and the representative of the SBP Network, Nicoleta Dumitru, thanked all TAG members who commented on the draft 0 of the PSEA clause for MoUs and Undertakings with SBP. A safeguarding specialist is being recruited (for now only until 31 March, end of UK budget year) to provide expert guidance and lead the work, inter alia, on the sex. Misconduct clause. Regarding the final draft of the P5 Senior PSEA Advisor ToRs, IOM is in the process of integrating/responding to the comments received in December. On the SMR report, all inputs received by TAG members had been shared with the OSC in early January. Inputs for the fact sheet were to be submitted by 28<sup>th</sup> of January. Following the survey run among the members of TAG and the PSEA Coordinators Community of Practice, the global PSEA workshop dates are now confirmed for 15th to 17th of September in Brindisi, Italy.

A PSEAH session is planned at the next IASC Principals meeting, inputs from TAG members are welcome. The mid-point update of the strategy which the TAG had prepared has been shared with deputies.

### 1. Harmonised Reporting Scheme (April-Sept 2024) – CHS Alliance

The CHS Alliance presented the <u>Harmonized Reporting Scheme (HRS)</u>. The HRS is a free, anonymous, and actionable tool to:

- Enhance accountability and transparency.
- Better understand SEAH by safely sharing anonymized data and analyzing patterns/trends.
- Inform SEAH risks mitigation, prevention and response efforts.
- Simplify reporting and tracking of SEAH incidents.

75 organizations are part of the HRS, mostly local NGOS, and more than 50 organizations are in discussion to join the HRS.

The goal of the HRS was to keep the data collection simple so organizations could use it easily. Four categories of data are collected: general information, information about the victim/survivor, information about the alleged perpetrator, and challenges/lessons learned. The participating organizations report

non-identifiable data on SEAH incidents using a form on a secure online platform, either on a rolling basis or every six months.

The platform is available in 4 languages, with 3 main sections: report new incidents, review reported incidents, and access real-time data analysis. The HRS has an added value as it simplifies reporting, is cost-effective, provides biannual analytical reports and dynamic graphs, and finally because the more organizations join the HRS the more accurate the data will be.

HRS is already working with various partners including the UN iReport and MDS. Interested TAG members can contact the CHS Alliance directly for more information on seah.hrs@chsalliance.org.

#### 2. Update on the TAG Workplan

A review of Workplan activities and progress was carried out. UNICEF mentioned their activities are well ongoing. Under activity 1.1.1, consultations have been conducted, and the feedback is being incorporated for the revised technical note. Regarding activity 1.2.2 on the implementation of the Victim Assistance Protocol, a concept note should be shared soon for review and feedback. The activities of the PSEAH Champion, WFP, are also on track, with good progress for activity 1.4.1 as the manual and KPIs are in the final stages. Activity 1.2.1, co-led by UNFPA and OVRA is ongoing with the aim to create two workstreams to cover more ground (resourcing and quality of survivor assistance). The SEARP-related activities, co-led by IOM and UNHCR, are also moving forward, consultations for activity 1.3.1 on the Revised Approach on CBCM. Activities 3.4.1 and 3.4.2 on mapping of needs and opportunities for resourcing PSEA will be finalized in Q1 and Q2 of 2025. IOM and UNHCR are also considering leaving the lead on this workstream to other TAG members and wish to ensure a smooth transition. UNDP/OSCSEA is considering merging activities 2.3.1 and 2.3.2 into one group and strengthening opportunities to highlight good leadership and establish good practices. The CHS Alliance-led activity 1.6.2 will see its results finalized in Q1 2025.

The IASC updated the TAG members on overall in-country coordination capacity (Commitment 3). In some countries, contracts are running out and Coordinators are leaving: in Syria by the end of March, in DRC by the end of February, in Nigeria by the end of January, and in Lebanon. There are 10 PSEACap deployments at the moment.
